The fragmentation of traditional music consumption patterns and the emergence of niche communities challenge conventional notions of mainstream and marginal music. Artists actively participate in these communities, strategically leveraging digital spaces to bypass traditional gatekeepers and connect directly with their target audience. The role of influencers as conduits for introducing experimental music to wider

audiences mirrors concepts of cultural intermediaries and the changing landscape of music promotion.

Indonesian contemporary and experimental music development in the 21st century unfolds as a complex interplay of musical hybridity, digitalization, semiotic expression, cultural authenticity, and shifting music consumption patterns. Applying concepts and theories from music science provides a comprehensive framework for understanding the intricacies of this dynamic musical evolution. As Indonesian musicians navigate the challenges and opportunities presented by the globalized music landscape, their creative responses reflect a profound understanding of theoretical constructs and a commitment to pushing the boundaries of sonic exploration in the pursuit of a distinctive and globally resonant musical identity.

Their commitment to carving out a distinctive space within the global music scene while navigating the complexities of contemporary challenges positions them as influencers and innovators.
